Pulled by Commissioner Putterman. Mr. Fisk and Mr. Sanchez appeared.

Mr. Fisk indicated was leasing his Qualifying Party License to the Business Licensee. Will ensure all paperwork is in order and would oversee Mr. Sanchez who he believes is well trained, until such time as he does get his license. Mr. Fisk indicated he is a full-time employee of Mastercare Pest Management Systems and has been for approximately 4 years. He wants to use Mr. Sanchez to service some accounts in Southern Arizona.

Mr. Sanchez indicated he intends to apply for a Qualifying Party License but was not in the process for testing for a Qualifying Party License.

Mr. Putterman expressed concerns regarding the concept of a rented license because the sole proprietor, Mr. Sanchez, isn’t even in the process for testing for a Qualifying Party License. It’s a shortcut to get to get into the business. Further, there would be insufficient oversight of a “rental” Qualifying Party and Business Licensee. It’s a common problem with rental licensees who are typically unfamiliar with the Rules and Laws.

MOTION: *To approve the application to activate Qualifying Party for existing business license in “B1” by Commissioner Black.
Seconded by Commissioner Baker.*

VOTE: 5-1 Motion carried.
(Commissioner Putterman dissenting).

2. Jerome Davis ("B8" Wood-Destroying Insect Inspection) AJF Engineering, Inc.

Pulled by Commissioner Putterman. Ms. Sharon Furman, co-owner of AJF Engineering, Inc. appeared.

Ms. Furman explained that Mr. Davis was on a vacation previously scheduled and could not appear. She explained that she is one of the business owners. In response to Mr. Putterman's questions regarding Mr. Davis' involvement in the business, and whether this would be an ongoing business, Ms. Furman explained that Mr. Davis will be involved in the business and has been involved in the business. He has been out in the field with each of her inspectors, he has been spending time in the office, and he has been reviewing WDIIIRs. She anticipates he will be in the office several times a week and will be very involved in training going to the field with each of her inspectors. Ms. Furman further indicated that this would be an ongoing business and that the long-term goal would be for Mr. Paul Furman to obtain his Qualifying Party License. However, he needs the requisite 3000 hours in the industry to do that.

MOTION: To approve the application to activate qualifying party for existing business license in "B8" by Commissioner Black.
Seconded by Commissioner DeVere.

VOTE: 6-0 Motion carried.

Pulled by Commissioner Putterman. Mr. Stephen Gatyas appeared.

Mr. Gatyas explained that Mr. Lannes could not appear today but that he was going to be the owner of the company and would participate in the “B” category pest control. He further indicated that Mr. Lannes would assist the sole proprietorship with safety issues. In response to questions from Commissioner Black, Mr. Gatyas indicated he held an Applicator’s License and had taken the Qualifying Party test 6-7 years previously but had not done so well. Mr. Gatyas explained that Mr. Lannes is currently employed by the City of Phoenix as a bus driver or in the City’s Transportation Department and that Mr. Lannes previously operated a sole proprietorship that included a non-compete clause, which has since expired. Mr. Gatyas is the only employee currently of that business.

Commissioner Burns expressed his concerns regarding Mr. Lannes’ ability to respond to emergencies if he is working full time for the City of Phoenix. Without an answer from Mr. Lannes directly to that question he is uncomfortable with approving the Qualifying Party application.

Commissioner Runbeck inquired of Staff if this question was addressed with Mr. Lannes to which Mr. Tolton responded they had not.

Further discussion ensued Commission members and the decision was made to table the matter until the September meeting.

Mr. Hughes withdrew his request because the Commission approved Mr. Jerry Davis' activation.

B. Applications to activate Qualifying Party for New or Existing Business License

Thomas L. Camp ("B1" General Pest & Public Health, "B2" Control of Wood-Destroying Insects, "B3" Right Of Way & Weed Control, "B5" Turf & Ornamental Horticulture and "B8" Wood-Destroying Insect Inspection) Quality Termite & Pest Control

Steven Mullenau, business owner for Quality Termite appeared.

MOTION: *To approve the Application to activate Qualifying Party and the new business license for Quality Termite & Pest Control, by Commissioner Black. Seconded by Commissioner Putterman.*

Mr. Putterman questioned whether Mr. Camp worked for the business to which Mr. Mullenaux responded in the affirmative although he is retired but can provide the appropriate amount of time to the business to comply with the law and rules. He would have oversight in operations and training as well.

Commissioner Baker questioned the use of "Quality" in the business name. Mr. Mullenaux responded by stating that they wanted to show quality workmanship and service, and the business name was approved by the Arizona Corporation Commission. Mr. Camp has not committed to being in the office 8 hours a day although he has committed to providing oversight and meeting with the business on a weekly basis, reviewing records and providing training. The business has one employee, Casey Christensen, who has approximately 1,700 hours towards the requisite 3,000 and is working on getting his Qualifying Party license.

Commissioner Burns also expressed concerns over the business name and his disapproval over the rental license concept and the similarity with Quality Pest Management, which appears to be one and the same to the consumer.

Mr. Mullenaux indicated this Commission has already set precedent in the past by approving similar business names, e.g., "Arizona" and "Pace." Commissioner Runbeck agreed.

Commissioner Black withdrew his Motion and Commissioner withdrew his Second.

MOTION: *To approve the Business License, by Commissioner Black.
Second by Commissioner DeVere.*

Discussion ensued regarding the scope of the Motion on the table. Ms. Gervase indicated that the agenda item can be addressed in two (2) separate Motions or in one combined.

VOTE: *3-3 Motion failed (Commissioners Burns, Baker and Putterman dissenting).*

Mr. Putterman reiterated his position. The Chairman requested legal advice from AAG Miles and Ms. Miles suggested that legal advice be provided in Executive Session.

MOTION: *To enter Executive Session, by Commissioner Baker.
Second by Commissioner DeVere.*

VOTE: *6-0 Motion carried*

EXECUTIVE SESSION: (from 9:35a.m. to 9:43a.m.)

Commissioner Runbeck advises the Commission that they have until September 21, 2006 before the application time runs out on this item. Options include tabling the matter until the September meeting.

MOTION: To deny the application of Quality Termite & Pest Control, LLC by Commissioner Burns.
Second by Commissioner Putterman, because A.R.S. section 32-2304(B)(18) allows the Commission to refuse to issue a business license if the name could be misleading. The name could be misleading to the public with Qualify Pest Management because in the minds of the public "pest", "termite", "control", and "management" are all the same..

VOTE: 4-2 Motion passed (Commissioners Runbeck and Black dissenting).

VII. Complaints

A. Robert Morency (APP)-Case #2006-004

MOTION: To suspend the applicator license of Robert Morency for nonpayment of renewal fees and dismiss the complaint without prejudice (license automatically revoked in one year), by Commissioner Black.
Seconded by Commissioner Putterman.

VOTE: 6-0 Motion carried.

B. Keith Breidenbach (APP)-Case # 2006-014

Mr. Dennis Hancock, owner of Alternative Termite & Pest Control, Mr. Breidenbach's employer, and the Applicator appeared.

Discussion ensued regarding how the drinking fountain contained pesticide residue by Commissioners Runbeck and Putterman. The Applicator explained that he became “dumbfounded” when he received the test results. Commissioner Baker discussed the amounts of residue actually detected and the applicator obviously made a mistake. Mr. Hancock explained that one of the chemicals detected was not even carried on his truck and the water fountain could have been contaminated at some earlier time. Commissioner Baker discussed the relative small size of a “nanogram.”

MOTION: *To accept proposed resolution and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner Black.
Seconded by Commissioner DeVere.*

VOTE: 6-0 *Motion carried.*

C. Catalina Landscape Maintenance (BL)/Murray Dew (QP)-Case #2005-095

Mr. Murray Dew appeared.

MOTION: *To accept proposed resolution and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner Black.
Seconded by Commissioner Baker.*

VOTE: 6-0 *Motion carried.*

Commissioner Burns after the vote, expressed concern regarding the number of CEU requirements contained within proposed Consent Agreements brought before the Commission for approval, too few if only two hours, and should be more significant, e.g., 8-10 hours. Staff indicated that they look at what is available and relevant to educate the licensee to not repeat the violation, without being overly burdensome or repetitive. Commissioner Putterman suggested that the Staff not limit it to courses already approved but to have the licensee seek out something and then present to staff for approval. Staff will look further into the matter.
